I am interested in applying for a:

- European Fellowship** (between 12 to 24 months at the UGR, any nationality, coming to Europe from any country in the world or moving within Europe)
 - Global Fellowship** (between 12 to 24 months in a non-associated Third Country, a mandatory 12-month return phase at the UGR, European nationals or long-term residents)
- I hereby confirm that, as of the call deadline, I had no more than eight (8) years of full-time equivalent research experience, calculated from the date on which I was awarded the doctoral degree, and duly supported by appropriate official documentation.
- I hereby confirm that, as of the call deadline, I complied with the applicable mobility rule, namely that I had not resided nor carried out my main activity (including work, studies, etc.) in the country of the beneficiary (for European Postdoctoral Fellowships) or in the country of the host organisation of the outgoing phase (for Global Postdoctoral Fellowships) for more than twelve (12) months within the thirty-six (36) months immediately preceding the call deadline.
- In the case of applying for a Global Postdoctoral Fellowship, I hereby confirm that I am a national or long-term resident of an EU Member State or a Horizon Europe Associated Country. Long-term residence shall be understood as a period of legal and continuous residence of at least five (5) consecutive years within one or more EU Member States or Horizon Europe Associated Countries, in accordance with the applicable [Work Programme](#) provisions.
- I hereby confirm that, under the MSCA-PF Call 2025, I did not submit a proposal with the same supervisor and host institution that obtained a score below 80%. For verification purposes, I enclose the corresponding Evaluation Summary Report (ESR).
- I hereby express my interest in receiving institutional support during the preparation and submission of the HE-MSCA-PF-2026 proposal to be submitted jointly with the Universidad de Granada. This support service will be available until 1 July 2026.

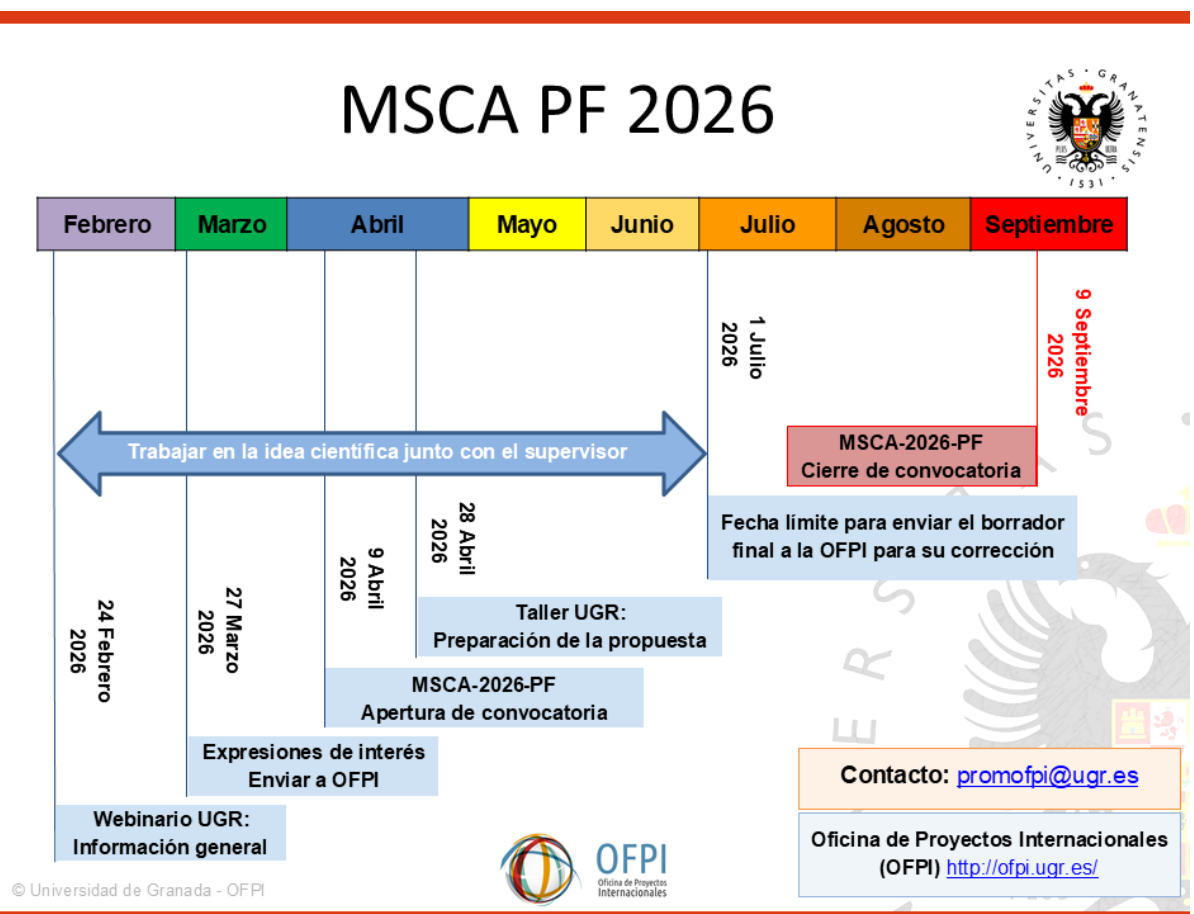

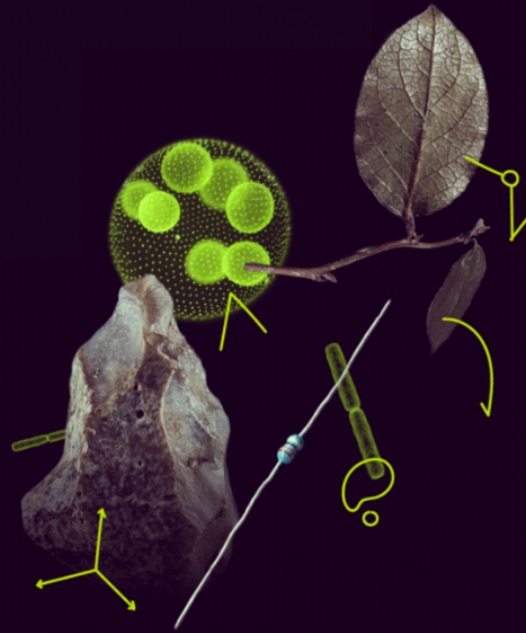
